Buyer agrees to pay interest on any unpaid purchases, beginning 30 days after the payment due date, at the rate of 1.5% per month; 18% per annum, or the maximum judicial rate, whichever is less. In signing this Application, Buyer agrees to all of the above and hereby grants permission for credit information to be verified by company(ies) and financial institution(s) that the Buyer has specified on this document and others that Show Me Rents, LLC becomes aware of during the credit review process and from time to time. The undersigned also understands that Show Me Rents, LLC will retain this Application, whether or not it is approved, and that Show Me Rents, LLC will consider this

Application as a continuing statement of the undersigned's financial position and situation until notified otherwise by the Buyer. In order for Show Me Rents, LLC to sell and to continue to sell to Buyer, Buyer hereby represents and warrants that it is solvent and that it pays its obligations as they become due. The preceding representation and warranty will be deemed to be repeated in each purchase by Buyer. Faxed documents will be deemed as original. No oral agreements will be accepted. The terms on this credit application/agreement overrides all others.

I understand that failure to return rented or leased personal property within the time specified in an agreement in writing may subject me to criminal liability and prosecution pursuant to § 578.150 RSMo. I understand that failure to return rented or leased personal property having a value of under \$500.00 may be a class A misdemeanor offense in Missouri, and that failure to return rented or leased personal property having a value of \$500.00 or more may be a class C Felony in Missouri. Returns of the rented or leased property at the end of the lease term, but does not pay the lease charges agreed upon will subject to prosecution under § 578.150 RSMo.

I understand that Show Me Rents, LLC reserves its right at all times to assert any Mechanics' and Materialmen's liens that it may be entitled to through the use of rented or leased equipment for improvements made on commercial property pursuant to Chapter 429, RSMo. I hereby agree to take any steps that may be necessary to assist Show Me Rents, LLC in perfecting a lien under said chapter, including but not limited to: (i) obtaining the consent of the lien from the owner of such commercial property pursuant to § 429.013 RSMo.; (ii) notifying Show Me Rents, LLC in writing of the intent to use the rented or leased equipment to make improvements on commercial property prior to the commencement of the use of the rented or leased equipment; and (iii) notifying Show Me Rents, LLC in writing of the address and telephone number of the owner of such commercial property prior to the commencement of the use of the rented or leased equipment on said commercial property.
